CURRENT CHANGES IN POLICE TRAINING UNDER THE CONDITIONS OF MARTIAL LAW IN UKRAINE

With the start of a full-scale war in Ukraine on February 24, 2022, all spheres of life of Ukrainian citizens underwent changes. The education system is no exception. In addition to the fact that the conditions in which future specialists of one or another field study have changed, the content and form of education have also undergone changes. This directly applies to the training of police officers who ensure the national security of the country.

The main directions of training future police officers in the modern conditions of life in our country are:

- 1) *Fire training*. The intensity of training with firearms has increased. Training on the tactics of fighting in city conditions has been strengthened. Shooting skills with various types of weapons are mastered.
- 2) *Tactical training*. There is training for actions in emergency situations related to military operations. Algorithms for responding to subversive and terrorist acts are sent. First aid and evacuation skills training is conducted.
- 3) *Psychological education*. Work with psychologists to increase stress resistance has become widespread. Methods of overcoming anxiety and panic are taught. The skills of working with people affected by military actions are being developed.
- 4) Legal training. New laws and regulatory acts adopted under martial law are being studied. The skills of working with military and civil authorities are mastered.
- 5) *Information training*. Increased attention is paid to teaching methods of countering enemy propaganda. Training on working with information in the conditions of information warfare is conducted.
- 6) Special training. Training of special purpose police units to perform special tasks under martial law [1, p. 93].

The purpose of training police officers under martial law is to:

- to increase the level of their readiness to perform tasks in the conditions of military operations;
 - provide them with the necessary knowledge, skills and abilities;
 - save people's lives and health [2, p.102].
- In addition, great attention is now being paid to mastering a foreign language by future police officers. This is an extremely important skill for police officers, not only now in martial law, but in general for successful work and professional development. This is due to a number of factors:

- Increasing international crime: the rise of transnational crime, such as human trafficking, cybercrime and terrorism, requires the cooperation of police officers from around the world. English is the lingua franca for communication and coordination in such cases.
- Growth in tourism: the increase in the number of tourists visiting the country makes
 English language skills essential for communicating with them, providing assistance and solving problems.
- Participation in international missions: Ukrainian police officers participate in UN peacekeeping missions and other international operations where English is the main language of communication.
- Increase in prestige: proficiency in English indicates a high level of professionalism of a police officer and increases the prestige of the police as a whole.
 - In Ukraine, English is studied by police officers at various stages of training:
- While studying in educational institutions where the study of the English language is a compulsory subject.
- During advanced training: at advanced training courses, police officers have the opportunity to improve their knowledge of the English language.
- As part of self-training: police officers can learn English on their own using online courses, textbooks and other resources.

There are a number of English language programs and courses designed specifically for police officers. These programs take into account the specifics of police work and contain vocabulary and phrases used in the everyday work of police officers. Here are some examples of English language programs for police officers:

- The program «English for patrol police» was developed by the British Council in Ukraine.
- The course «English for law enforcement officers» was developed by the National Academy of Internal Affairs of Ukraine.
- The online course «English for police officers» was developed by the Ministry of Internal Affairs of Ukraine.

Proficiency in English gives police officers a number of advantages: the ability to communicate with colleagues from other countries; access to information and resources in English; increasing career prospects; increasing personal and professional self-esteem. Therefore, learning English is an important component of training police officers.

Thanks to high-quality training, Ukrainian police officers successfully perform their tasks under martial law, ensuring public safety and order.
