CONCEPT OF NATIONAL SECURITY OF UKRAINE UNDER MARTIAL LAW

In recent decades, the situation in the world has been characterized by a dynamic system of development of world relations. Ukraine occupies one of the leading positions in this process and the national security of the state plays a key role.

The National Security Concept of Ukraine is the main set of documents that define key directions in maintaining and ensuring the security of the individual, state, and society in internal and external directions. National security is the preservation of the security of the people as evidence of the sovereignty of the state and its only source of power.

The state, in its policy of ensuring national security and socio-economic orientation, places the main emphasis on creating a strategy that meets the national interests of the people and their effective protection at all levels of life. Taking into account the significant economic, military, and technical potential, the country has prospects for integration into the global economic system. Already at this stage, its role in resolving a number of international situations and maintaining security while respecting international rights has increased.

In the economic sphere, Ukraine shows the ability to maintain its role and its place in the face of existing instability in the global economic system and challenges caused by martial law. It is strengthening its position in the face of ever-increasing threats to its national security. The increase in the country's independence at the external and internal levels is caused by Russia's armed aggression.

In the field of international security, the Ukrainian government adheres to legal methods of conflict resolution on the terms of diplomacy and cooperation, creating equal relationships with other countries based on legal norms. The use of military potential in solving problems is relevant only if all other methods have not shown their effectiveness.

Ensuring national security is carried out through the implementation of the following strategic concepts:

- growth of the country's economy;
- development of cultural and scientific potential;
- maintaining the country's defense capability;
- rationalization of the use of natural resources;

- maintaining stability in the implementation of strategies with equal cooperation at the international level;
 - main directions in the national security strategy;
 - mobilization of the domestic economy;
 - implementation of trade relations at the global level;
 - ensuring the general well-being of people and stable wages;
 - maintaining stability in all spheres of society;
 - ensuring the country's security at the external and internal levels;
 - increasing competitiveness in the global market.

The key focus in the concept of national security of Ukraine, in addition to defense capability and security, is to ensure a decent standard of living for people in the state. This is its socio-political orientation.

The strategic goals and objectives of state and national security are the maintenance and protection of the existing constitutional system, the sovereignty of the country, its integrity at the territorial and state levels, the preservation of rights and stability in politics and the economy, and ensuring the security of the population from internal and external threats.

Maintaining national security is carried out by strengthening the efficiency of law enforcement agencies, and government oversight bodies, carrying out preventive measures in activities related to the prevention and detection of crime and applying strategies to combat criminalization, especially under martial law. The main emphasis is on creating conditions for the complete absence of reasons for the spread of corruption since it is a serious obstacle to maintaining the stability of the country at the international level and significantly impedes the implementation of strategies to ensure national and public security. To maintain state security, the following strategic priorities exist:

- improving the system of functioning of the executive branch;
- creation and implementation of a system that detects and suppresses illegal activities;
- development of tools for conflict prevention at the social and international levels;
- strengthening security in the information sphere, detecting threats and neutralizing them;
- tightening measures to ensure the safety and security of citizens from the influence of criminal and terrorist groups, as well as other propaganda systems.

It can be argued that the modern system of security concepts represents a very effective scheme for the functioning of the state. However, there are a lot of questions and shortcomings that have an external impact on the level of effectiveness and implementation of the strategy, in particular:

- level of corruption;
- the need for a high level of funding;
- lack of personnel, etc.

All the problems presented are pressing shortcomings of Ukrainian reality; accordingly, in combating corruption, increasing the effectiveness of financial activities, and training highly qualified personnel, it will be possible to achieve the desired results not only within the framework of the Concept but also in other areas.
