поліцейськими і в'язнями, що може позитивно вплинути на їхню реабілітацію та повернення до суспільства. Коли поліцейські виявляють повагу до в'язнів, слухають їхні проблеми та потреби, це допомагає створити сприятливу атмосферу для співпраці та взаєморозуміння.

Правильне спілкування також сприяє зменшенню конфліктних ситуацій та насильства в середині установ покарання. Коли поліцейські вміють ефективно комунікувати з в'язнями, це допомагає уникнути непотрібних проблем та забезпечити безпеку всіх присутніх.

Крім того, правильне спілкування поліцейських з в'язнями сприяє покращенню їхнього самопочуття та психологічного стану. В'язні, які відчуваються повагу та розуміння, можуть бути більш мотивованими до покращення своєї поведінки та зміни негативних звичок. Тому, важливість правильного спілкування поліцейських з особами, які відбувають покарання, полягає в побудові довіри, зменшенні конфліктних ситуацій та насильства, а також покращенні самопочуття та мотивації в'язнів.

ENGLISH IN THE ACTIVITIES OF THE NATIONAL POLICE OF UKRAINE

English has become an international language due to historical events. The United Kingdom, located on a separate island in Western Europe, gained the status of a leading maritime empire. This British empire became the largest country in the

history of mankind, owning a fifth of the land mass of our planet. Thus, English culture and language spread to North America, India, China, Australia, Africa, and other regions. As a result, the language has become the language of international relations, used by the subjects of relations. When many countries are involved in international relations, English is often chosen as a common language of communication.

The issue of the importance of language for the activities of the Ukrainian police is quite diverse, as each case requires an individual approach. In my opinion, Ukraine is taking the right reform measures and is in line with the Constitution of Ukraine. According to the Constitution of Ukraine, the Ukrainian language is the state language of Ukraine, and the state is obliged to ensure its comprehensive development and functioning in all spheres of public life throughout the country. Ukraine also guarantees the free development, use and protection of other languages of national minorities in Ukraine, as well as promotes the study of languages of international communication. The use of languages in Ukraine is regulated by the Constitution and laws.

According to the Law of Ukraine «On the National Police», international police cooperation is regulated as follows:

- 1. Interaction of the police with relevant bodies of other states and international organizations is based on international agreements, as well as on the charters and rules of international organizations to which Ukraine is a member.
- 2. Representatives of the Police may be sent to international organizations and foreign countries to coordinate cooperation in cases within the competence of the Police.
- 3. Police officers may participate in international peacekeeping and security operations.

In our opinion, foreign language is of the utmost importance for patrol police, as patrol police officers are the face of the National Police of Ukraine and are the first people foreigners see when they visit our country. In Europe, a patrol police officer can assist citizens in any situation, so we, as associate members of the European Union, must meet high standards of service delivery. Germans and French people can only ask for help from a Ukrainian patrol policeman in English. The security police, special police and special police are engaged in very specialized work, so an international language is not mandatory for them.

English also requires attention, as Ukraine is a member of numerous international organizations, including Interpol. Representatives of these organizations will have to interact in English, not in the language of each agent or my own. So, if we look at this issue in a broader context, we can understand that learning English is essential for police officers around the world to fight international crime [3].

When teaching foreign languages, great attention should be paid to expanding vocabulary, in particular in the form of stable phrases and blocks that are actively used in the professional language of law enforcement. When creating vocabulary

learning exercises, it is important to focus on concepts and expressions that relate to the special vocabulary of the field and contribute to the development of communication skills necessary for law enforcement.

Thus, the development of language skills is a complex process that requires constant improvement, an active approach and consideration of the context of communication. The effectiveness of this process depends on the right choice of teaching materials and methods, as well as the use of appropriate forms and modes of learning.
